

Aboriginal Heritage Act 1972 (AHA)

Notice of assessment of Aboriginal heritage places by the Aboriginal Cultural Material Committee (ACMC)

The ACMC is the specialist heritage advisory body to the Minister for Aboriginal Affairs (the Minister). The functions of the ACMC include evaluating, on behalf of the community, the importance of places and objects alleged to be associated with Aboriginal people and providing advice to the Minister on all Aboriginal heritage matters across the State.

Following the decision of the Supreme Court in *Robinson v Fielding [2015] WASC 108*, the Minister has directed the ACMC to reassess 35 Aboriginal heritage places. The list below provides an overview the ACMC's assessments of these places. Please note that this list is updated following ACMC meetings.
